- Check Security Features Of Documents with UV-light (if possible)
- At Big Events often there are UV-lights available



- UV-lights: Desk-Lights about 35-40 Euro
- UV-Money-Tester about 4 Euro (!!!)



If You Haven't Seen A Document Before That Has Been Shown

 Continue Assurance, But Declare The Assurance Candidate That This Document Is New To You, So You Have To Give Less Points Allocated



Otherwise: Finish Assurance With The Reason Why You Finish.



You Ever Have The Option Of "Late Decision"

What Does This Mean?



Answer:

Maybe the ID documents have been too weak and the assurer reconsidered the amount of points. Usually he should notify you of this by E-mail.



Foreign Passports Non-European Documents

 Check The Documents About Their Security Features But Consider That Documents With Less Security Features Allways Exists (i.e. Italy IDcards -> like Grey Germany Drivers Licence)



Foreign Passports Non-European Documents

If You Havent An UV-Money-Tester Its Too Weak To Test On One Document Only.
If One Of These Documents Is Weak And One Is Ok, Continue Assurance But Give Less Points



Foreign Passports Non-European Documents

 Give Other Assurers A Chance To Check These Documents Who Are Familiar With These Documents.
